

Php 1.916 Million
Released for Barangay Officials Death Benefits
For the Month of November 2014

The Department of Budget and Management (DBM) has released to the Department of the Interior and Local Government the amount of **One Million Nine Hundred Sixteen Thousand Pesos (Php 1,196,000.00)** to settle the claims of the beneficiaries of **143** deceased barangay officials for the month of November 2014. Of the number, **20** are Punong Barangays (PB), **102** are Sangguniang Barangay Members (SBM), **9** are Barangay Secretaries (BS), **11** are Barangay Treasurers (BT) and **1** Sangguniang Kabataan Chairman (SKC).


