SUBJECT : PROVINCIAL GOVERNORS, CITY AND MUNICIPAL MAYORS, LIGA NG MGA BARANGAY PROVINCIAL / CITY / MUNICIPAL CHAPTER PRESIDENTS, DILG REGIONAL DIRECTORS, ARMM DILG REGIONAL SECRETARY AND ALL OTHERS CONCERNED

SUBJECT : ATTENDANCE TO THE 2017 YEAR-END ASSESSMENT AND SUMMIT ON BARANGAY REFORMS OF THE LIGA NG MGA BARANGAY SA PILIPINAS (LnB)

The Liga ng mga Barangay sa Pilipinas (LnB) will hold its 2017 Year-End Assessment and Summit on Barangay Reforms on November 29-30, 2017 and December 1, 2017 at the Marriott Grand Ballroom, Newport City Complex, Pasay City.

The objectives of the activity are 1) to review and revisit the outputs of July 2017's strategic consultation; 2) to orient and familiarize the participants on AmBisyon 2040; 3) to commit to perform policies and strategic actions consistent with local and national goals; and, 4) to perform towards achieving the desired barangay reforms in the areas of social protection; peace, order and public safety; financial management and fiscal reforms; and environmental management.

In this connection, through the request of Hon. Edmund R. Abesamis, LnB National President, Barangay Officials or their representatives coming from the 81 Provinces, 17 LGUs in NCR and 21 independent component cities and charter cities from all over the country, are hereby encouraged to participate in the said activity on official business. The payment of applicable travelling expenses and a registration fee per participant, to defray the costs of hotel accommodation, meals and congress materials, may be authorized chargeable against their respective local funds, subject to the availability hereof, and to the usual accounting and auditing requirements and to all pertinent laws, rules and regulations. Provided, however, that the travelling expenses and registration fee shall not be charged against the 20% component of the Internal Revenue Allotment or from whatever source which may prejudice poverty reduction efforts.

The LnB-National President shall submit a post-activity report to the Undersigned, through the National Barangay Operations Office, within one (1) month after the conduct of the said assembly.

All DILG Regional Directors and Field Officers are likewise directed to cause the dissemination of this Circular in their respective jurisdiction.
