HEALTH AND ENVIRONMENT (PHE) CONFERENCE

The Commission on Population (POPCOM) is organizing the 7<sup>th</sup> Population, Health and Environment (PHE) Conference scheduled to take place on November 06-07, 2018 at Bohol Plaza Resort and Restaurant, Mayacabac, Dausi, Bohol. With the theme “Investing in Resiliency of Most at Risk Groups/ Sectors on the Population Health Impacts of Climate Change”, this conference will be attended by PHE Network members and partners: national and local government units (LGUs), PHE practitioners, program managers, advocates, policymakers, educators, faith-based groups, IPs organizations, health service providers, policymakers and academe.

The objectives of the conference are: (1) to highlight the current efforts and initiatives on PHE approaches success and challenges at the national and local level interventions; (2) to sustain and advance PHE efforts and increase interest among local government units (LGUs), national agencies, non-state actors, and support agencies including bilateral and multilateral agencies; (3) to identify needs and priorities and resources on the significance of population, health and environment interrelationship towards attaining the sustainable development goals, climate agreements, and the national environment health action plan.

In this regard, all Local Chief Executives, Provincial/ Municipal Population Officers, Provincial/ Municipal Health Officers, Municipal Planning Development Officers and other LGU staff are encouraged to participate in the above-mentioned activity. The conference has a registration fee of Php 6,500.00 per delegate/ participant inclusive of meals and conference kit. Transportation, accommodation and other incidental expenses related to the event shall be shouldered by the participating LGUs chargeable against their respective local funds, subject to the usual accounting and auditing rules and procedures.
