**MEMORANDUM CIRCULAR**

**TO : ALL PROVINCIAL GOVERNORS, CITY MAYORS, MUNICIPAL MAYORS, BARMM REGIONAL GOVERNOR, DILG REGIONAL DIRECTORS, AND OTHERS CONCERNED**

**SUBJECT : PRESIDENTS' ACADEMY OF THE PHILIPPINE COUNCILORS LEAGUE**

The Philippine Councilors League (PCL), through the PCL Legislative Academy, will be conducting the Presidents' Academy on October 23-25, 2019 at the Waterfront Hotel, Davao City.

As represented, there will be technical sessions on Transformational Leadership, Smart Local Governance as well as the Indicators for Good Local Governance. A planning-workshop on the proposed PCL Local Chapters Performance Based Management System: The Seal for Good PCL Local Chapter also forms part of the activity.


In view of the above, and upon the request of Councilors Danilo L. Dayanghirang and Jose Nelson Sala Sr., Interim National Chairman and Interim National President respectively, PCL, all City Mayors and Municipal Mayors are encouraged to allow the members of the sanggunians who are Interim National and Island Officers of the PCL, as well as the Provincial Federation and City Chapter Presidents of the said League, to attend the said activity, on official business.

The payment of applicable traveling expenses, and registration fee, if any, to cover the cost of hotel accommodation, meals and activity materials, per participant, may be authorized chargeable against available local funds, in accordance with, and subject to applicable limitations prescribed in COA Circular NO. 2012-003 dated October 29, 2012, to the usual accounting and auditing requirements and to all pertinent laws, rules and regulations. Likewise, the participating local government officials are reminded of the provisions of DILG Memorandum Circular No. 2018-25 dated February 28, 2018, prohibiting local government officials and employees from entering, staying and/or playing at gambling casinos.

The PCL Interim National President shall submit a Post-Activity Report to the Secretary of Interior and Local Government, through the Director of the Bureau of Local Government Supervision, within fifteen (15) days after the conduct of the said activity, with the following prescribed format:

- I. Executive Brief;
- II. List of Participants;
- III. Outputs of Technical Sessions;
- IV. Issues and Agreements or Recommendations, if any;
- V. Total Fees and Disbursements; and
- VI. Appendices, if any.
