






ESTABLISHMENT OF VIOLENCE AGAINST WOMEN (VAW) DESK IN EVERY BARANGAY

This is accordance with Magna Carta of Women Act (RA 9710). The DILG, together with the Philippine Commission on Women (PCW), DSWD, DepEd) and DOH issued JMC 2010-2 which provides for the establishment of a VAW Desk in every barangay to ensure that violence against women cases are fully addressed in a gender-responsive manner.

DASHBOARD ON BARANGAY GOVERNANCE




Dashboard on Barangay Governance, similar to an automobile dashboard where driver could monitor at a glance the vehicle's major functions shall provide a snapshot of KPI (key performance indicators) related to good governance. It shall provide cars as signs about barangay governance, telling us whether we are in the right track or not; and those signs shall prompt us, whether to refine or refocus our interventions accordingly.

Summaries of KPIs are grouped by thematic areas: 1) **Presence of basic facilities** 2) **Institutional Capacity**, measured in terms of the presence of barangay-based institutions, and 3) **Adherence to Accountability and Transparency**.

Visual presentation is presented similar to 'gauge' for simplicity and minimum distractions.


BARANGAY CITIZEN'S CHARTER
