## DILG: Charges filed vs perpetrator of viral post telling couples to practice physical distancing after sex

DILG Secretary Eduardo M. Año has formally filed a complaint against the perpetrator of fake news circulated on social media allegedly quoting him as advising couples to practice physical distancing after sex.

This was confirmed by DILG Undersecretary and Spokesperson Jonathan E. Malaya after the Philippine National Police (PNP) completed its investigation and identified the culprit as Gabriel Marvin Cabier, a 26-year-old resident of Cebu City.

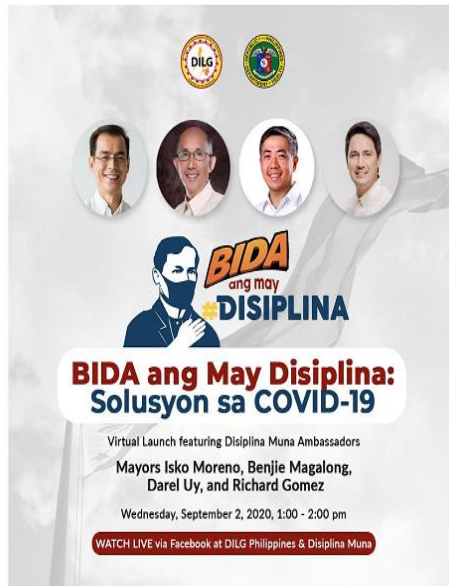

## DILG Pampanga, AFP talk further actions on anti-insurgency

DILG Pampanga Director Myrvi Apostol-Fabia and Lieutenant Colonel Felix Valdez, Commanding Officer of the 48th Infantry Brigade of the Philippine Army, laid down the succeeding strategies following the success in the surrender of a total of 24 rebels, further aiming to ultimately curb the violent extremist movement in the locality.

Immediately following the ceremonial awarding of the cash-aid assistance to 14 former



rebels through the Enhanced Comprehensive Local Integration Program (ECLIP), anti-insurgency focus group members sat down for a meeting on Wednesday, September 2, 2020, to further discuss provincial actions to finally put an end in the local movement against the government.

The meeting forms part of the activities under the Ending Local Communist Armed Conflict (ELCAC) Program of the national government from the Executive Order No. 70 on the whole-of-nation approach against violent rebel groups and terrorists.

## **DILG Soccsksargen adds more focal persons to strengthen localization of EO 70 in the region**

This development came as the additional list of target barangays for the Region was released according to DILG XII Regional Director Josephine Cabrido-Leysa, CESO III.

There were 1,325 target barangays as the 2020 nationwide target of which Region XII has 103 identified barangays. This includes the original 63 target barangays and the additional 40 barangays which were added by the National Task Force (NTF) on ELCAC to be targeted

for CY 2020.

Director Leysa, in an earlier statement recalled that *“the advocacy on Ending Local Communist Armed Conflict (ELCAC) has been sustained by the Department”* and all the adjustments are in place as a way of ensuring that all the efforts toward the realization of insurgent-free communities will not be paralyzed, even during the dark days of Covid 19 pandemic.

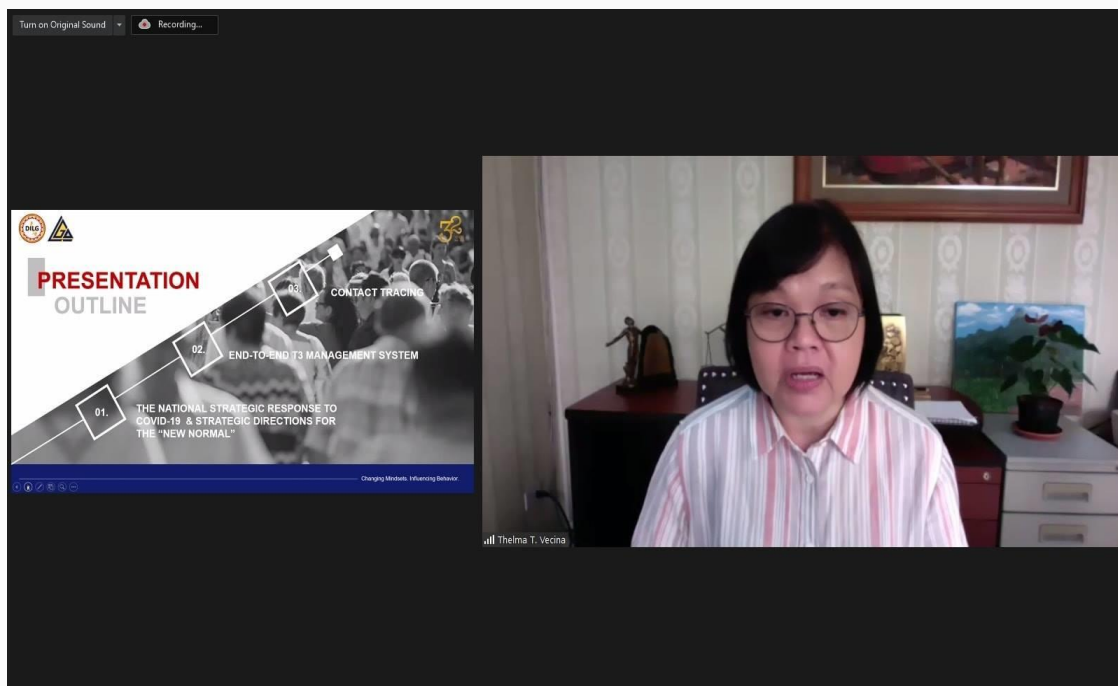
